1ST ACADEMY SCHOOL OF INSURANCE GUARANTEE

1st Academy School of Insurance guarantees that if you complete the necessary requirements (read the textbook(s) provided, attend all classes, study practice exams, and complete the online modules), you will pass the state exam. If not, or if the student is dismissed for unsatisfactory progress, they may be re-admitted to another class at no cost. This offer is valid for 60 days from the date of the initial course that you attended. If 1st Academy should substantially fail to furnish the instruction or services agreed upon in the enrollment agreement, we shall provide a 100% refund.

Criteria for Enrollment: Minimum age 18, and must provide proof of high school diploma or equivalency. A driver's license (or valid photo ID) must be provided. Students must show a willingness to dedicate time and effort to study and complete course material, maintaining professional conduct at all times, as 1st Academy School of Insurance is a school of integrity that exercises fair ethical practices and maintains an atmosphere of comfort for all students. If any student of 1st Academy School of Insurance fails to maintain professional conduct which may include usage of profanity and disruptive behavior, the student will be referred to the refund policy. Only one excused absence and one 15-minute tardy grace will be allowed per course or the student will be required to pay a \$100 re-enrollment fee.

Credits from other schools or courses are not transferable.

70% is the minimum grade considered satisfactory. However, we recommend to strive for the 90's before scheduling the state licensing exam.

The deadline for enrollment is 1 business day prior to the 1st day of class. Should 1st Academy make a change in the enrollment agreement, the student will be offered a fair chance to complete the same program within approximately the same time frame with no additional fee and the students signed approval of agreement stated without coercion.

COMPANY **POLICIES**

CANCELLATION AND REFUND POLICY

- Should 1st Academy substantially fail to furnish the instruction or services agreed upon in the enrollment agreement, a 100% refund will be awarded
- If a student cancels the enrollment before the start of the training program, 1st Academy shall refund the student all monies paid by the student less than 10% of the tuition or \$150 whichever is less.
- Complimentary refresher courses/tutoring are allowed for students who fail to meet the minimum grade of 70% for up to six months without penalty. 70% is the minimum passing grade on classroom quizzes and tests.
- If a student withdraws or is expelled after the start of the training program and before the completion of more than 60% of the program, 1st Academy shall refund to the student a pro-rata amount of tuition based upon student attendance minus 10% or \$150, whichever is less.
- If a student fails to attend class, withdraws, or is expelled by the institution after completion of more than 60% of the program, the student may forfeit any pro rata share of tuition.
- · All above-stated excess monies collected shall be refunded within 15 calendar days after the date of cancellation by a student, the date of termination by 1st Academy, and the last day of an authorized leave of absence if the student fails to return after the period of said absence; or the last day of attendance of a student whichever is applicable.

CANCELLATION AND REFUND POLICY, (Cont'd)

- Books, educational supplies, or equipment for individual use are not included in the above-stated policy for refund, and a separate refund will be paid to the student by 1st Academy if the materials are returned in the same condition as received.
- The period of a student's attendance is measured from the 1st day of instruction as outlined in the enrollment agreement through the student's last day of actual attendance regardless of absences. The period of time for a training program is the period outlined in the enrollment agreement. Tuition must be calculated using the tuition and fees outlined in the enrollment agreement and does not include books, educational supplies, and equipment that are listed separately from the tuition and fees.
- Excused absence: car accident, death in the family, and medical emergency.
- Self-Study/Correspondence courses begin on the day of registration. The estimated time of completion is projected over 20 days, however, the student is allowed to complete the course for certification within 90 days of registration.
- A refund of tuition less 10% or \$150, whichever is less will be granted if the student returns books and materials in the same condition received within 7 days of self-study registration.
- A termination fee of 10% of tuition or \$150, whichever is less for cancellation up to the 15th day. All tuition will be forfeited for cancellations after the 15th day.

STUDENT CONDUCT

Students will be *terminated* for violation of any of the following rules and regulations. All students are expected to act maturely and are required to respect other students and faculty members

- Any student caught cheating on exams or assignments or committing plagiarism.
- Any sexual misconduct, i.e.: unprofessional advances, vulgar or offensive language, innuendoes, or harassment on the School's premises.
- 3. Disruptive, abusive, or unprofessional behavior.
- 4. Any student under the influence or in possession of alcohol, marijuana, or any controlled substances on the School's premises.
- 5. Any student having possession of firearms or weapons of any nature on the School's premises.
- 6. Threat or physical altercation with staff, faculty, or another student.
